Key Responsibilities

 - Participate in the recruitment of team members that match the needs and interests of participants, and the organisation.
- Ensure teams demonstrate adherence to safety and positive behaviour plans.
- Risks and safety issues are identified, plans to manage risks are in place, and incidents are reported and resolved appropriately.
- Adheres to NDIS quality and safeguarding reporting obligations.
- Complete provider reports and participant related documentation as required by the funding body.
- Coaching and mentoring of staff, volunteers and trainees to deliver on agreed outcomes, operating within a self-organised model to embed contemporary practice under the guidance of the Operations Lead.
 - Support workers demonstrate strong collaborative relationships with participants, families and guardians.
 - o Partnerships with internal and external stakeholders are developed and maintained.
 - o Participate in networking opportunities and actively promote Uniting services.
 - Individual and support workers training needs are identified and acted upon within budget in collaboration with the Operations Lead
- Innovative leadership and supervision is provided to deliver on agreed outcomes where team members share responsibility for:
 - o Collaborating to determine resource needs, within budget.
 - Collecting data to identify and deliver on continuous improvement plans.
 - Co-creating a professionally enriching team culture that evidences organisational values.
- Information and client management systems are up to date, and statistics and reports are provided to the Operations Leads and Senior Managers as required or requested.
- Ensure rosters align with funding and Employee Collective Agreement and are covered by support workers.
- Support skills are maintained and strengthened by actively taking part in the support roster and covering unplanned leave.
- Ensures expenses remain within budget and approval is sought from the relevant delegate for unbudgeted expenses.
